

# PRIVACY POLICY

## Introduction

This privacy policy describes how TSR OU («TSR», «we», «us», «our») in accordance with the Regulation of the European Parliament and of Council No. 2016/679 as of April 27, 2016. and other applicable legal norms collects, stores, uses and protects your personal data using or interacting with tsrpay.com, tokensale.tsrpay.com or account.tokensale.tsrpay.com (Websites).

TSR cannot comply the requirements of the normative acts of all the jurisdictions throughout the world. By using the Websites and Services, you agree to comply with the law of your jurisdiction and bear sole responsibility for the non-compliance.

By using the Websites, you knowingly and unconditionally give TSR the consent to collect, use and transfer your personal data in accordance with this Privacy Policy, and accept the Terms of Service.

At any time, you can withdraw your consent to the processing of personal data, which does not affect the validity of the data processed prior to the moment of withdrawal.

Please read our Privacy Policy carefully to get a clear idea as to why and how we collect, use, protect or otherwise handle your personal data.

TSR may amend this Privacy Policy. If significant changes are made, TSR will issue a notice to enable you to review the changes before they come into force. If you do not agree with any changes, you can close your account. By continuing using the TSR Services after publishing or sending notice of changes to this Privacy Policy, you hereby agree to the updated Privacy Policy.

## 1. Collected information

### 1.1. Information you provide to TSR

#### Registration

You provide the information necessary to create and protect your account, including your email address and password.

#### Profile

If you wish to purchase tokens, you may be asked to include in the profile a true identifying information such as your first and last name, date of birth, citizenship, country and address and provide proof of identity, source of funds, etc. directly or through a third party with the purpose of fulfilling the requirements of the normative acts on the prevention of money laundering and terrorist financing (AML), and the implementation of KYC / CDD procedures. TSR has the right to verify and receive from third parties the information submitted by you.

To purchase tokens, you will also need to specify the payment method and payment details (for example, the address of the digital wallet or bank account).

You are responsible for the relevance and authenticity of the information specified in the account. You are not entitled to use the TSR Services unless you are 18 years of age or older.

#### Submission and upload

TSR collects your personal data, including when you submit, insert, or upload it during the use of the Services, for example when uploading an identity confirmation or residence address.

### 1.2. Cookies, web beacons and similar technologies

TSR can use cookies and similar technologies (for example, web beacons, one-pixel images, ad tags and device IDs) to recognize you and / or your device (s) as a returning user, customize services, content and advertising, evaluate the results of marketing activities and collect information about your computer or another access device. You can manage cookies in your browser settings and through other means.

### 1.3. Your device and location

When you access or exit TSR Websites (including plug-ins or cookies, and similar technology from third-party websites), TSR obtains the URL of the website from which you logged in and the website to which you transferred. In addition, TSR also receives information about your IP address, proxy server, operating system, web browser, add-ons, device identifier, and capabilities, and/or an Internet service provider or mobile operator. When using TSR Websites from a mobile device, this device sends TSR information about your location. Most devices enable you to prevent from sending location data to TSR. In this case, the TSR will be guided by your settings.

### 1.4. Other

If TSR begins to collect fundamentally different personal data or significantly changes the way your data is used, TSR will notify you, and may also amend this Privacy Policy.

## 2. Ways of using your data

### 2.1. Communications

To communicate with you, e-mail, notifications on TSR websites, messages will be used. TSR will send you messages about security and other aspects of providing the Services. In addition, TSR sends reminders and advertisements from TSR and TSR partners. Please note that you cannot refuse to receive service messages from TSR, including security notifications and other applicable notifications.

### 2.2. Marketing

TSR uses Participant data and related content in invitations and messages aimed at promoting the participation and expansion of the network, involvement and TSR Services.

### 2.3. Support service

TSR uses the data (including, likely, your messages) necessary to respond to claims and questions about the Services (for example, errors), as well as for their consideration and solution.

### 2.4. Aggregated statistics

TSR uses your information to obtain aggregated statistics that does not allow you to identify yourself. For example, TSR can use your data to generate statistics relating to visitors to TSR sites, their profession or industry, and the distribution of website users by demographic characteristics.

### 2.5. Security and investigations

TSR uses your data (including your messages), if necessary to ensure the security or investigation of potential fraud or other violations of the TSR Terms of Service or this Privacy Policy and / or attempts to cause harm to TSR Participants and Visitors.

### 2.6. Storage and use of information

TSR will store your information in its database for the purpose of providing the Services. TSR has the right to conclude a contract with third parties for the purpose of storing and processing information. TSR also has the right to transfer information to a company that is part of the TSR group.

TSR will not sell or share your information for the marketing purposes to third parties without your explicit consent.

## 3. Dissemination of information

### 3.1. Service providers

TSR involves third parties in the provision of the Services (for example, maintenance, analysis, audit, payment, detection of fraud, marketing and development). They access your data to the extent that it is reasonably necessary to perform these tasks on behalf of the TSR. They are bound by the obligation to TSR not to disclose or use this data for other purposes.

### 3.2. Disclosure by virtue of the law

It is possible that TSR will be required to disclose information about you in accordance with legal requirements, subpoena or other judicial processes, and in cases where the TSR has reason to believe that disclosure is necessary for: (1) investigation, prevention of or action against alleged or actual offenses or to assist state law enforcement agencies; (2) enforcing the terms of any agreements with you; (3) investigation of any claims or charges from third parties and defense from them; (4) ensuring the security and integrity of the TSR Services (for example, by providing access to companies facing similar threats); (5) implementing or protecting the rights or security of TSR, TSR Participants and employees or others. TSR strives to notify the Participants of the properly stated requirements regarding their personal data when it considers it appropriate, unless it is prohibited by law or by order of the court, and also if the request is not urgent. The TSR can challenge such claims if it considers that these requests are excessively broad, unclear or lack the proper authority. However, TSR does not promise to challenge every claim.

## 4. Rights and obligations of the Participant

### 4.1. Saving data

TSR keeps personal information provided by you as long as your account exists or as long as it is necessary to provide you with the Services if there is no legal requirement to save data for a longer period of time. TSR saves your data and stores your profile until you decide to close your account. Individual data are retained for a period of time specified by the requirements of normative acts. In some cases, the TSR can store individual data in anonymized or aggregated form.

### 4.2. The right to access, monitor, modify, transfer and delete your personal data

TSR provides various tools for managing your data - from changing or correcting data included in your profile. You can view or edit personal information in your account. You can delete personal information or your account by contacting TSR Customer Support.

The Participant is entitled to use the right to data portability by contacting TSR support and undertaking all necessary steps to confirm his identity.

### 4.3. Closing an account

You have the right to request the termination of processing your data.

If you decide to close your TSR account, your personal data will be deleted within 30 days from the date of your application, except for the cases listed below.

TSR stores your personal data even after the account closure, if it is reasonably necessary to fulfill TSR legal obligations (including law enforcement requests), legal requirements, as well as to resolve disputes, ensure security, prevent fraud or abuse, enforce the provisions of the TSR Terms of Service or to fulfill your request to refuse further communications from TSR.

## 5. Other important information

### 5.1. Security

TSR implements security measures to protect your data, in particular, the HTTPS protocol. TSR regularly checks its systems for vulnerabilities and attacks in order to ensure the adequate security of your data, including protection against unauthorized and illegal processing and against accidental loss, destruction or damage, using appropriate technical and organizational measures.

Reliable protection of your information is a prerequisite for our work. Your personal data is stored in a secure storage and is subject to special protection by SSL encryption. (Secure Sockets Layer). Profiles of our users are not indexed by search engines. Access to your information is available only to those employees who carry out verification of your identification.
